As an extension to the Drama curriculum, I have arranged an opportunity for students to attend a performance of a The Government Inspector which is being presented by 'Splendid Productions' in our Main Auditorium on the morning of

This performance will support the work of students who are currently following the Level 2 BTEC Acting course as well as providing a useful introduction to Year 9 students who may be considering opting for BTEC Acting next year.

The play is a satirical prod at power, privilege, corruption and classism set in a small provincial town whose public servants – including the untrustworthy Mayor – are told they are to be assessed by an anonymous official: The Government Inspector.

In Splendid's new adaptation, a highly skilled cast of three will populate an entire town of panicking officials, dismayed citizens and feckless fantasists in a fast-paced, one-hour performance which asks: if absolute power corrupts absolutely, what happens when you only have a tiny bit of power?

To cover the costs of hosting this performance, we are asking for a voluntary contribution of £6 from each student; as I hope you will agree, this offers an opportunity for students to see high-quality professional theatre at an extremely reasonable price!

The Governors have a policy on charging and remission which includes the following: 'There may be cases of family hardship which make it difficult for students to take part in particular activities for which a charge is made' and 'they recognise that circumstances may make it difficult for parents, who would wish to do so, to offer voluntary contributions.' We are anxious that students should not be excluded from activities for financial reasons and parents who find themselves in this situation are invited to make this known to Mrs N Logan, nlogan@ormistonsudbury.co.uk in confidence so that the possibility of assistance can be considered.
